Workshop on data quality in registration dossiers

REACH, Europe's overarching chemicals regulation, has an impact on a wide range of other EU legislations, e.g. classification and labelling, consumer product and toy safety, food contact materials, construction products, workers safety, waste and water. Under REACH, companies are obliged to register their substances and to provide information on their hazards, uses, potential risks and necessary risk management measures.

The REACH Compliance project is a joint project of the German Federal Institute for Risk Assessment (BfR) and the German Environment Agency (UBA). It investigates the availability of human health and environmental data in the REACH registrations of chemicals.

During the workshop, the latest results of the REACH Compliance project on registrations of chemicals above the registration volume of 100 tonnes per year will be presented and discussed. Representatives from national and international authorities. NGOs and the industry will present further data and strategies on topics relevant for REACH Compliance. ECHA will present the outcome of ten years of evaluation under REACH in connection to the objectives of its regulatory strategy and the ambition to meet the targets of the World Summit on Sustainable Development 2002. It will also introduce the perspective on the post-registration era, highlighting the importance of maintaining good quality dossiers. The main aim of this workshop is to promote the dialogue among REACH stakeholders and to support registrants with recommendations for dossier improvements.
